Classroom Instruction

Prerequisites – You must be at least 13 years old to attend. The classroom consists of 30 credit hours: lesson topics and credit hours attached.

Evaluations and Grading – The students are graded on daily tests and a final exam. Anyone making 80% or above is considered to have passed the course and receives a certificate. Any student who does not earn 80% or better on the final test is given an opportunity to retake the test at another time or to retake the class. The retake of the test or the entire class is given at no charge to the student. If the student doesn't come back to retake the test for the class within the following 90 days, their completion status will move from "Incomplete" to a "Fail".

Un-excused absence- No Show – Our classes consist of 30 hours of course work. These hours are broken up over 5 days. Each student must attend all 5 classes and take the final test achieving an 80% or better to receive credit for the class and a certificate. Two absences are considered not fulfilling the requirements for the class. The student can either stop attending at that time or start back with another scheduled class. At the completion of 30 hours (5 days) the student would then need to pass the final test achieving an 80% or better. Any make up test will need to be scheduled with office staff. Students achieving 80% or better, will receive a certificate.

Excused absence – If the student is absent due to illness and a doctor note is provided, the student can make up the day missed. Due to the complexity of the classroom instruction and the learning process of information building on itself, the student must make-up that class during one of the next corresponding class sessions. If a family emergency is experienced, then Thompson management will make decisions at that time based on the specific information provided.

MakeUp Classes – If the student only has one absence, they must attend another class in order to meet the criteria of fulfilling the requirements for the class and the student can either stop attending at that time or start back with another scheduled class or can simply make up the day that was missed during another class. At the completion of 30 hours (5 days) that student would then need to pass the final test achieving an 80% or better. Any make up test will need to be scheduled with office staff and then if the student achieves 80% or better we will mail a certificate.

Tardiness – If the student is over 15 minutes late then they are considered absent and will have to make up the day within the next 6 months during another session of the material.

Classroom – (June-August) Summer Classes are every other week Monday through Friday (September – May) During School year the classes are five consecutive Sundays • Behind the wheel instruction is scheduled separately.

Cancellation and Refund Policy - Full copy can be seen on our ThompsonDriving.com website.

Refund of the behind the wheel instruction is usually not needed because they are paid at the time of scheduling. However, if you pre-pay for lessons you do not intend to take, the unused portions will be refunded if before 48 hours of the lesson. Any unused portions after 90 days will forfeited. Any no-shows will be charged the full amount of the lesson. Classroom instruction is non-refundable after 6 months. You may attend any available class during the next 6 months, at no charge. Any credits for behind the wheel left unused will only be held for **90 days**, following the 90 days the credit will be lost. A full refund to any student who cancels the enrollment contract within seventy-two (72) hours (until midnight of the third day excluding Saturdays, Sundays, or legal holidays) after the enrollment contract is executed. If an applicant is not accepted for enrollment by a school the applicant is entitled to a full refund of monies paid less an application fee not to exceed twenty-five dollars (\$25). The effective date of the termination, for refund purposes, shall be the last day of attendance.

Behind the Wheel (BTW)

Prerequisites – You must have a valid learners permit issued by the Arkansas State Police. Each lesson is 2 hours in length, 1 hr. and 50 minutes driving in the vehicle and a 10 minute consultation with the parents to recap the lesson. The 10 minute consultation is for the parent(s) benefit practicing and advancement. This is HIGHLY recommended.

Evaluations and Grading – The behind the wheel instruction is graded on performance and the ability to handle the tasks given. Any student needing additional instruction will be informed of that need. All students who complete the program (minimum of 8 hours of instruction) receive a certificate of completion. Neither the state nor insurance companies require you to "Pass the course" to receive a documentation of lessons completed.

Un-excused absence- No Show – The instructor will wait 15 minutes for the student. After that, the lesson is cancelled and marked as a no-show, and the lesson fee is forfeited. Due to the dynamics of the behind the wheel courses, there is no make-up. The student just schedules another lesson. Arrangements may be made to come late based on a specific situation, but will only be the time remaining.

Excused absence – If the office is notified 48 hours or more ahead of time, then the scheduled lesson can be rescheduled. If we are notified within the 48 hours, the student will be charged the full amount unless they have a doctor note.

Tardiness – The instructor will wait 15 minutes for the student, after that the lesson is cancelled, marked as a no-show and the fee is forfeited. If an instructor has to wait for a parent to arrive following the lesson, we have the discretion to charge a late fee. That feel is priced at \$71 per hour.

Complaint Process - Same as Classroom - See above

Schedule – We schedule behind the wheel lessons starting at 8am and go until the last lesson scheduled until 8:15pm, 7 days a week most of the year, after school, and on weekends. We schedule lessons a couple of days in advance, allowing us to work around the student's ever changing busy schedules with the least amount of cancelations. We recommend a minimum of 2 hours practice for every 1 hour taught by the instructor. The more practice a student receives, the more we can cover.

Acknowledgement Please Read The Following and Initial

Parent Initials – I understand the 48 hour cancellation policy. You must call 48 hours in advance of your scheduled lesson if you are unable to keep your scheduled appointment. If the appointment is cancelled before the 48 hour window you can change, move, cancel or get refunded the cost of the lesson but AFTER the 48 hour window, you will be charged the FULL amount of the lesson even though you weren't able to take it. We are scheduling you a personal vehicle, with a dedicated instructor. Any lessons scheduled for Sunday must be called into the office by Friday at 5pm.

Parent Initials – Each student that is to drive in our car MUST have a valid Original Arkansas Drivers Permit, or Intermediate License or Class D Driver's License (No Copies). We abide by Arkansas Law and will require any restrictions present on their official document be enforced. If you have to wear glasses/contacts then we will require you to have those in order to drive. (ARCode §27-16-802(2017)

Parent Initials – "No Drive Condition" would be for anything that would keep a student from going on a lesson. We reserve the right to say that a student is not able to drive. These conditions could include, but are not limited to: (1) If the student is wearing shoes that we determine aren't safe, they will not drive. (2) If the student is under the influence of any unknown substance, then they will not drive. (3) If the student isn't rested or appears to not be at 100%, or lacking adequate energy to drive safely, they will not drive. (4) If personal hygiene is an issue and an odor is generally offensive to others, then the student will not drive. If student is unable to drive the lesson fee will be forfeited.

Parent Initials – I have given all information regarding medical information to Thompson Driving that could possibility affect the new drivers ability. I understand by getting in a car has risks and giving us this information is vital in keeping everyone safe!

______ Parent Initials – Each lesson emphasizes new skills that require practice, if the student doesn't get enough driving they may not advance to the next set of skills. Every lesson has calculated risks and we will not take any unnecessary risk with the student. They must be ready to handle the skills to advance.

CONSENT AND RELEASE
